National Teams -- will typically practice 6 hours per week and will compete in 9--11 tournaments, at least one out of state National Qualifier and either USAV Junior Olympics or AAU Nationals.

Fees include: Gym costs, salaries and expenses for coaches, uniforms, practice and tournament balls, tournament entry fees, admin fees and printing costs.

Fees do not include: Transportation to and from practice or tournaments, hotel, membership in USAV, food, and out of state tournament expenses.

Payments made after the 15th will be considered late! **NO EXCEPTIONS!**

Please note, a \$25.00 late fee will be assessed for each month your payment is late and a \$25.00 fee will be assessed if your check is returned.
(Payments will not be accepted at practices/tournaments by coaches or board members.)

I agree and understand that my child's participation in Tri County Volleyball Association is contingent on the timely payment of the financial obligation set forth above. I further agree and understand that Tri County Volleyball Association, in reliance on my child's participation in this organization, will initially be expending various funds for my child's benefit. **By signing this agreement, I agree and promise to pay to Tri County Volleyball Association, the Participation Fees, at the place for payment and according to the terms of payment as stated above until the entire Participation Fee has been paid in full, in order to compensate Tri County Volleyball Association for such expenses, regardless of whether my child participation with this organization is terminated voluntarily or involuntarily after the date of this Agreement.** Absent any other written agreement between the parties, all unpaid amounts shall be due by the final scheduled payment date. The annual interest on all unpaid and matured amounts will be the highest rate allowed by law.

On default in the payment of this agreement, the unpaid principal balance and earned interest on this agreement shall become immediately due at the election of Tri County Volleyball Association. If this agreement is given to an attorney for collection, or if suit is brought for collection, then I agree to pay for Tri County Volleyball, all cost of collection, including reasonable attorney's fees and court costs, in addition to other amounts due. Reasonable attorney's fees shall be 10% of all amounts due unless either party pleads otherwise.

Please Initial the below statements to indicate your understanding/acceptance of the statements

- _____ I understand that there are fees and dues associated with my athlete to play for TCVA.
- _____ I agree that I will pay the associated fees and dues in full, as outlined in the contract, and understand that once I sign the contract, no refunds are given.
- _____ I understand that National and regional teams participate in some Stay and play tournaments where we are required to book a hotel room through the booking company provided by the tournament/club.
- _____ I understand all monthly payments must be paid by the 15th of the month. Late payments will incur a \$25 late fee and my athlete will not be able to participate in practice or tournaments until payment is received.
- _____ I understand that my athlete's tuition is non-refundable;; if we chose to not participate, regardless of the reason. I understand I am still responsible for paying the remainder, regardless of when we chose not to participate.
- _____ I understand that I am paying for practice while playtime during competition is earned with commitment and production. Playing time is not guaranteed and is left to the discretion of the coach.
