FINANCIAL AGREEMENT

Initial: _____ I agree that I will work with my parents to pay the associated costs in full and understand that failure to pay the due/fees on time will result in not being allowed to participate in team practice, tournaments, or any TCVA events until we are current or otherwise agreed upon by the treasurer.

Initial: _____ I understand that by paying fees to the club and being a registered member with the club guarantees my training and development as an athlete but does not guarantee play time.

ATTENDANCE POLICY

Initial: _____ I understand that there are 1 - 3 training sessions per week, as related to the team level (local, regional, and national).

Initial: _____ I understand my parents are **ONLY** allowed in the gym during the last 30 minutes of practice due to space availability, interferences, and distractions.

Initial: _____ I understand that, if I will be missing practice, it is my responsibility to contact the coach, not through a friend or another parent, **AT LEAST** 24 hours prior to the scheduled training time so that they can plan accordingly.

Initial: _____ I understand that school, school sports, illness, and family deaths are all excused absences. However, missing training sessions **COULD** result in a negative impact on play time as each athlete present has an opportunity for high repetition, growth, and development.

Initial: _____ I will work with my parents to ensure I make it to practices and tournaments on time (15 minutes prior for practices and as determined by coaches prior to tournaments). I understand if I am late, not ready on time, or in inappropriate attire, there may be disciplinary action as deemed at the coach's sole discretion.

CODE OF CONDUCT

Initial: _____ I will maintain a positive attitude toward volleyball and my teammates.

Initial: _____ I will help create a positive environment for both myself and my team on and off the court. This includes not reacting negatively when an error occurs but instead, providing encouragement and support.

Initial: _____ I will respect my teammates, coaches, officials, and opponents.

Initial: _____ I will be a good role model for all other players within and out of the club.

Initial: _____ I will leave non – volleyball related issues at the gym door and come to practice and tournaments ready to focus.

Initial: _____ I will practice hard, play hard, and strive to do my best at all times.

Initial: _____ I will acknowledge my mistakes, when applicable, and take the responsibility for them. I will never make excuses or place blame on my teammates.

Initial: _____ I will do my best to be humble when successful and courteous in defeat.

Initial: _____ I will ensure I balance my time so that my other commitments do not hinder my commitment to my team.

Initial: _____ I understand it is my responsibility to get adequate sleep before and during tournaments and to maintain a balanced diet so to allow myself to compete at the highest level possible.

Initial: _____ I understand I am not allowed to use any electronic devices, including but not limited to cell phones, iPods, and iPads, during tournament warm ups, ref/scorekeeping duties, and team events (unless otherwise given permission by your coach).

Initial: _____ I understand it is my responsibility to address any concerns related to play time with coach. This should **ONLY** occur before or after practices **NEVER** during before, during, or immediately following a tournament.

I understand that with any failure to comply with the terms of this contract, TCVA reserves the right to deem as being contrary to the positive development and growth of TCVA and my team and could result in dismissal from the club.
